WHEREAS, The City of San Diego hired Dr. James Claus as a consultant to assist in the promulgation of sign control legislation in the City of San Diego; and

WHEREAS, as a result of such efforts, the Council agreed to enact legislation as recommended; and

WHEREAS, the City Council adopted Ordinance No. 11000 (New Series), effective March 6, 1973, to include in the San Diego Municipal Code Section 95.0100 et seq. for the control and administration of on-premise signs; and

WHEREAS, the sections were amended thereafter to clarify the provisions contained therein; and

WHEREAS, the United Business Commission filed suit in the Superior Court of San Diego on August 15, 1974, to enjoin the enforcement of said Code sections and to have said sections declared unconstitutional; and

WHEREAS, it is now necessary to defend the City in said Superior Court action; and

WHEREAS, pursuant to such defense, it is necessary to consult with and call Dr. Claus as an expert witness; and

WHEREAS, such defense requires the payment of consultation fees, expert witness fees and other legal fees; and

WHEREAS, it is necessary to provide funds to defray such expenses; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

City of San Diego</u>, Superior Court No. 356994.
