

RESOLUTION No. 217580

Adopted on JAN 26 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City-owned property listed as Site No. 9, Coronado Avenue and Beyer Road (Blvd.), in Resolution No. 214556, adopted October 29, 1975, as shown on Document No. 753163 on file in the office of the City Clerk, is hereby redesignated from "low-income senior citizen and handicapped" to "mixed housing."

2. That a mixed-housing and multi-funding program be utilized for development of the above site (Coronado Avenue and Beyer Blvd.) with 20% of said housing designated for low-income elderly and 80% designated for low-income family housing.

3. That the City Manager is hereby authorized to execute a one year agreement with the SAN YSIDRO URBAN COUNCIL, INC., a nonprofit corporation, with regard to approximately 24 acres located at Coronado Avenue and Beyer Boulevard, whereby the corporation is granted the exclusive right to be recognized by City as the entity which shall plan for the development of the premises for future use as a mixed housing, senior citizen and family residential project.
