BE IT FURTHER RESOLVED, that pursuant to this resolution, in the event any certificate holder named herein fails to pay the business license fees called for under Municipal Code Section 31.0344 and in the manner provided in Section 31.0140 within twenty (20) days of the adoption of this resolution and commence operation of his taxicab for which the certificate is now issued within ninety (90) days of the adoption of this resolution, the City Manager be and he is hereby directed to revoke the certificate and to present to this City Council the next prospective individual owner/operator applicant as determined by the date of filing an application.


