BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the following findings are adopted in regard to the significant environmental impacts identified in E.I.R.

No. 76-08-05P:

1. A professional survey, collection of artifacts and photographic and written recordation of finds performed on the site mitigates the archaeological impact of the development.

2. There is no feasible mitigation to reduce the exposure of the site to air pollutants except denial of the project which is economically and socially detrimental to the general welfare of the City in that needed housing would be denied to citizens of the region.
