

RESOLUTION NO. 217600Adopted on FEB 2 1977

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Wayne L. Ramsey	City Treasurer	\$750	Mr. Ramsey is a Senior Typist in the License Division. He suggested a new Business License Application form that combines on one form the information contained on two forms. The new form is typed at the computer and thus prevents a duplication of material and effort. This suggestion saves the City an estimate \$7,507 annually.
Donald Fitterer	Transportation	\$200	Mr. Fitterer is an Electronic Technician in the Communications and Electrical Division. He suggested that malfunctioning battery packs for two-way radios be repaired rather than buying new battery packs. This is done by removing the old cells and replacing them with new cells. This saves approximately \$4,252 per year. This is a partial award pending a final 12-month review.
Alvin D. Wilkinson	General Services	\$195	Mr. Wilkinson is a Building Services Technician II in the Buildings Division. He suggested that new seats and backs be purchased for chairs rather than having the old seats and backs reupholstered. This saves the City \$1,967 per year.
Arturo Allas	Utilities	\$100	Mr. Allas worked in the Utilities Customer Service Section at the time of his suggestion. He suggested that two forms be replaced with a Computer Reminder Card. This saves \$1,019 per year in form mailing, and personnel costs.
