WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Tony Oson	General Services	\$75	Mr. Oson is an Electrician Apprentice in the Buildings Division. He constructed a test unit for scoreboards using spare parts. This tester saves the City \$748 per year by reducing the time needed to repair scoreboards.
Donald H. McCleary James D. Cole	Transportation	\$75	Both suggesters are Utility Workers in the Street Division. They suggested that a deburring tool be purchased to remove the rough edges of aluminum panels used for signs. This saves the City an estimated \$1,473 annually in the time needed for filing. This is a partial award pending final 12-month review.
Martha C. Rodriguez	Transportation	\$45	Ms. Rodriguez is an Intermediate Typist in the Communications and Electrical Division. She suggested that traffic signal and street light service requests be sorted daily rather than biweekly. This saves the City \$470 per year.
Roland Ashley	Transportation	\$25	Mr. Ashley is a Utility Worker in the Street Division. He suggested improvement to the Duomat Vibrate Surface Compactor. The shift control handle was extended to keep the extremities of the operator a safe distance from the rollers.
Tex W. Clark	Utilities	\$20	Mr. Clark is a Water Plant Operation Supervisor in the Utilities Quality Division. He suggested that wooden baffles be constructed in filters to prevent the filter media from being removed by a high flow. Savings are expected to be substantial; this is a partial
