Robert W. Edgett, Jr.	Police	\$20	Mr. Edgett is a Police Officer. His safety suggestion resulted in the relocation of the control panels in Police Ambulances to prevent possible head injuries.
Phillip T. Stone	Park and Recreation	\$10	Mr. Stone is a Lifeguard in the Aquatics Division. He suggested that the speed limit be painted on the Ventura Place boardwalk to notify bicyclists of the safe speed and to aid in keeping motor vehicles off the walk.
Robert K. Hartnett	Fire	\$10	Mr. Hartnett is a Firefighter. He suggested that a San Diego business telephone be installed at Fire Station #40 to reduce the telephone bill. This saves the City \$121 per year.
