BE IT RESOLVED, by the Council of The City of San Diego as follows:

R77-1243

1. That the bid of \$25,942.00 by DBX, Inc. dba Perry Electric, a corporation, for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF ROUTE 54 - REO DRIVE AND TONAWANDA DRIVE/VALLEY ROAD in the City of San Diego, California is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757153.
2. That the expenditure of \$24,731.00 is hereby authorized out of the Gas Tax Fund (Fund 220), and that the expenditure of \$6,919.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF ROUTE 54 - REO DRIVE AND TONAWANDA DRIVE/VALLEY ROAD in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$6,870.00 from CIP No. 52-040.3(5) to the Gas Tax Unallocated Reserve, CIP No. 90-220.
