APPROVING MAP OF LA JOLLA UNIVERSITY ESTATES

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by JAMES L. HALE, a Licensed Land Surveyor, entitled LA JOLLA UNIVERSITY ESTATES Being a subdivision of a portion of Lot "1" in Pueblo Lot 1312, in the City of San Diego, County of San Diego, State of California, according to Partition Map No. 968, of Pueblo Lots 1312 and 1313 of said Pueblo Lands of San Diego, filed in the office of County Recorder of San Diego County, December 13, 1905, a portion of Pueblo Lot 1298 of Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the office of County Recorder of San Diego County, November 14, 1921, as Miscellaneous Map No. 36, together with a portion of Horizon Way and a portion of La Jolla Shores Drive as vacated and closed to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Ellentown Road, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council


