


RESOLUTION No. 217624Adopted on FEB 2 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to transfer \$4,500 within Capital Outlay Fund 245 of The City of San Diego to Fund 244, Object Account 3297, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the conversion of traffic signal and street lighting services and related costs at the intersections of MONTEZUMA ROAD at COLLWOOD BOULEVARD, MONTEZUMA ROAD at 54TH STREET, MONTEZUMA ROAD at 55TH STREET, and MONTEZUMA ROAD at YERBA SANTA ROAD, in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all necessary work in conjunction with the above-referenced project pursuant to the recommendation of the City Manager and the submission of his estimates indicating said work can be done more economically by City Forces than if let by contract.
