RESOLUTION OF INTENTION NO. _____

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF KALE STREET, ADJACENT TO WHAT WAS KNOWN AS THE "DEPOT GROUNDS" ON SORRENTO LANDS AND TOWNSITE, MAPS 362 AND 483, VACATED BY SCC 87450, NOW PART OF PUEBLO LOTS 1357 AND 1359, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of a portion of KALE STREET adjacent to what was known as the "Depot Grounds" on Sorrento Lands and Townsite, Maps 362 and 483, vacated by SCC 87450, now part of Pueblo Lots 1357 and 1359, as more particularly shown on Map No. 13834-B, on file in the office of the City Clerk as Document No. 758181.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 p.m., MAR 9 1977, in the Council Chamber, on the twelfth floor of the City Administration Building, The Charles C. Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.
