BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Council opposes the request from San Diego Gas & Electric Company to the California Public Utilities Commission ("PUC") to reduce the 1977 Budget for underground conversion.

BE IT FURTHER RESOLVED, that the City Manager and City Attorney be and they are hereby directed to make inquiry of the PUC regarding the cost of undergrounding projects and the relation of those costs to annual undergrounding allocations, and also to the benefit and potential of having undergrounding projects performed by public or private bid.
