

RESOLUTION No. 217641Adopted on **FEB 2 1977**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with the SAN DIEGO CITY AND COUNTY WAR AGAINST LITTER COMMITTEE, INC., a California nonprofit corporation, for services to contribute to the cultural, recreational, economic and promotional well-being of the community by amending the agreement on file in the office of the City Clerk as Document No. 757087, to provide an additional sum of \$12,000 for compensation, under the terms and conditions set forth in the form of First Amendment to Agreement on file in the office of the City Clerk as Document No. 758220.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer from Transient Occupancy Tax Fund 224 (Contingency Reserve) to Fund 224, Object Account 3299, the sum of \$12,000 to be expended solely and exclusively for the purpose of providing funds for these services.

3. That the City Manager be and he is hereby authorized to submit an application to KEEP AMERICA BEAUTIFUL, INC., a national nonprofit public service organization, for The City of San Diego to participate in the Clean Community System.
