BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That this Council hereby adopts the following findings of fact in support of its decision to acquire land through eminent domain for the purpose of constructing, operating, and maintaining a public park to be known as Adobe Falls Park as is referenced in City Council Resolution No. 217643.

Said findings are as follows:

- 1. The public interest and necessity require the proposed project because it is the acquisition and preservation of the Adobe Falls area as a Resource-Based Natural Park. Such acquisition is in accord with the Progress Guide and General Plan of the City of San Diego (map dated January 27, 1972). The acquisition of Adobe Falls Natural Park "as soon as possible" is an objective of the Navajo Community Plan. The Adobe Falls area has been designated Historic Site \$80 by the City of San Diego Historical Site Board.
- 2. The proposed project is planned and located in amanner that will be most compatible with the greatest public good and least private injury because the location is dictated by the presence of the resource itself; namely the falls, pools, streambed, flora and fauna of the Adobe Falls area.

- 3. The property sought to be acquired is necessary for the proposed project because:
 - a. The parcel proposed for condemnation includes a portion of the streambed, pools, flora and fauna which are known as Adobe Falls.
 - b. The parcel will provide the only reasonable public access to the Adobe Falls area. Public access to the area from Mill Peak Road is not considered feasible due to the steep terrain.
