2. That the expenditure of \$250,000.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for WATER MAIN REPLACEMENT GROUP 415, including Addendum A, in the City of San Diego, and related costs.
