APPROVING MAP OF EMPIRE DEVELOPMENTS UNIT NO. 5

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by RAYMOND F. HALL, Jr., Registered Civil Engineer, and entitled "EMPIRE DEVELOPMENTS UNIT NO. 5 Being a subdivision of a portion of Lot 45 of The Highlands, in The City of San Diego, County of San Diego, State of California, according to Map thereof No. 284, filed in the office of the County Recorder of San Diego County, March 16, 1887.", is made in the manner and form prescribed by law and conforms to the surrounding surveys, that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portion of Brinell Street and a portion of Dagget Street for public purposes, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer facilities as granted and shown on said map and subject to the conditions set forth thereon.
