


RESOLUTION No. 217669Adopted on FEB 9 1977

That the acceptance by the City Manager of that deed of AVCO COMMUNITY DEVELOPERS, INC: , which acquired title as Rancho Bernardo Inc., a California corporation, executed in favor of The City of San Diego, bearing date of December 22, 1976, conveying to said City the permanent easement and right of way to construct, reconstruct, maintain, operate and repair a storm drain or drains affecting a portion of Rancho San Bernardo according to Map thereof filed in the office of the County Recorder of San Diego County, in Book 2, Page 462 of Patents, as more particularly described in said deed, be and the same is hereby approved.
