That the acceptance by the City Manager of that deed of GLENN S. and MAIMIE PEDEN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of December 8, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 14 of Gardena Home Tract, according to Map thereof No. 1248 filed in the office of the County Recorder April 11, 1910, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named GARDENA AVENUE.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder.
