

RESOLUTION No. 217674Adopted on **FEB 9 1977**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE ROMAN CATHOLIC BISHOP OF SAN DIEGO, a Corporation Sole, executed in favor of The City of San Diego, bearing date of October 20, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across portions of Lots 20 and 21 of University Knolls Unit No. 1 according to Map thereof No. 3900, filed in the office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SANTA PAULA DRIVE.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
