

**RESOLUTION No. 217675**Adopted on **FEB 9 1977**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of BGN CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date of September 13, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lots 9, 10, 11, 12 and 13 of Schultz Addition to San Ysidro, according to Map thereof No. 1758, filed in the Office of the County Recorder July 7, 1923, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SAN YSIDRO BOULEVARD.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder.
