A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM BY AMENDING DOCUMENT NO. 754397, AS ADOPTED AND AMENDED THEREIN, BY ADDING C.I.P. PROJECT NO. 73-131, 69TH AND MOHAWK PUMP PLANT, AND AUTHORIZE THE TRANSFER WITHIN THE 502 FUND OF \$2,000 FROM UNALLOCATED RESERVE (69.79) TO WATER CONSTRUCTION OUTLAY-CITY FORCE (66.92) TO PROVIDE FUNDS FOR THE ABOVE PURPOSE.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That pursuant to Section 2, subsection 23 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 754397, as amended, be and the same is further amended by adding thereto C.I.P. Project No. 73-131, 69th and Mohawk Pump Plant.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer within the 502 Fund the sum of \$2,000 from the Unallocated Reserve (69.79) to Water Construction Outlay-City Force (66.92) to provide funds for the above C.I.P. Project No. 73-131.
