


**RESOLUTION No. 217684**Adopted on **FEB 9 1977**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a Lease Agreement with the SAN DIEGO COMMUNITY COLLEGE DISTRICT, for the purpose of operating and maintaining an off-campus educational aviation facility on a portion of Lot 16, Montgomery Field, for a period of 39 months terminating June 30, 1980, at a monthly rental of \$325, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 758256.

BE IT FURTHER RESOLVED, that the requirements of Council Policy 700-10 providing for a fee appraisal and a three year rent review are hereby waived.
