WHEREAS, the City Council referred the SRI Report to the Centre City Development Corporation (CCDC) for its recommendation; and

WHEREAS, the CCDC has reviewed the report and submitted its recommendations to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That, in accordance with the provisions of the Operating Agreement between The City of San Diego and CCDC, CCDC be and it is hereby authorized to contract with the consultant of its choice (following, as near as practicable, the selection of said consultant in accordance with City Council Policy No. 300-7) to study the overall financial feasibility of a new convention center in the Centre City area as recommended in SRI's Report with specific regard to the economics and financial planning thereof with a report to be furnished to this City Council on or before June 30, 1977; provided, however, that the fee for such consultant services shall not exceed \$135,000.
- 2. That the City Auditor and Comptroller be and he is hereby authorized to transfer within the Transient Occupancy Tax Fund 223 the sum of \$135,000 from Facility Reserve (52.89) to Centre City Development Corporation (52.59) to be used solely and exclusively to provide funds for the above purpose.

3. That the City Council encourages the CCDC to appoint a committee advisory to them for the purpose of providing community input during the course of studying the concept of a convention facility.
