

RESOLUTION NO. 217691Adopted on FEB 16 1977

BE IT RESOLVED, by the Council of the City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, a "Contract Form for Survey" with the DEPARTMENT OF PARKS AND RECREATION, STATE OF CALIFORNIA, for a fifty percent (50%) matching fund grant in the amount of \$4,879.00, City to match with in-kind services for a four (4) months Historical Inventory Survey of approximately Two Hundred Fifty-seven (257) historical structures in the City of San Diego located within the area of LaJolla. The survey is to be conducted under the terms and conditions set forth in "Contract Form for Survey" on file in the office of the City Clerk as Document No. 758311 (form of contract).

BE IT FURTHER RESOLVED, that an expenditure not to exceed \$4,879.00 is hereby authorized to be advanced from General Purpose Revolving Fund (534) to provide funds to meet obligations incurred in conducting said survey acknowledging that the terms and conditions of the "Contract Form for Survey" guarantees the repayment of said advance upon completion of the project.
