
BE IT RESOLVED, by the Council of The City of San Diego as follows:

Nachant, Inc., a corporation, for the CONSTRUCTION OF BROWN FIELD METAL BUILDINGS, including Additive Alternates #1 and #2 in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757578.

That the expenditure of \$127,931.00 is hereby authorized out of the Economic Development Corporation Fund (Fund 314) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF BROWN FIELD METAL BUILDINGS, including Additive Alternates #1 and #2 in the City of San Diego, and related costs.
