

BE IT RESOLVED, by the Council of The City of San Diego as follows: *R77-1308*

The the bid of Hawthorne Machinery Co. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE BULLDOZER (with blade & ripper) CATERPILLAR, Model D6C, for a cost of \$65,630.00; terms net 30 days plus sales tax less trade-in allowance of \$7,800.00 for City Bulldozer with a guaranteed repurchase price of \$35,000.00 in 5 years or 8000 service hours; ONE BULLDOZER (with bucket and ripper) CATERPILLAR MODEL 955L for a cost of \$56,030.00, terms net 30 days plus sales tax less trade-in allowance of \$9,600.00 for City Bulldozer with a guaranteed repurchase price of \$29,500.00 in 5 years or 8000 service hours; ONE BULLDOZER (with blade and ripper) CATERPILLAR MODEL D4D for a cost of \$37,910.00, terms net 30 days plus sales tax less trade-in allowance of \$6,500.00 for City Bulldozer with a guaranteed repurchase price of \$19,400.00 in 5 years or 8000 service hours.
