of Rancho San Bernardo, in the City of San Diego, County of
San Diego, State of California, according to Map thereof filed
in the office of the County Recorder of San Diego County,
in Book 2, Page 462 of Patents.", is made in the manner and
form prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is
hereby approved and accepted; and said Council hereby accepts
on behalf of the public, the following: Matinal Road, Pinzon
Way, and Carranza Drive for public purposes; and said streets
are hereby declared to be public streets and dedicated to
the public use.


