WHEREAS, The City of San Diego is the owner of certain easement for drainage purposes affecting a portion of Lot 12, Block 2, Essex Place and a portion of Pueblo Lot 1125 according to the Map thereof No. 1097 filed in the Office of the County Recorder of San Diego County; and

WHEREAS, the Engineering and Development Department has requested that the City quitclaim to DEVILLE DEVELOPMENT & CONSTRUCTION INC., a California Corporation, its interest in and to said easement; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City desires to negotiate the sale of said easement to Deville Development & Construction Inc., under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permits the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished only by negotiation; and

WHEREAS, the value of the property right sought, as determined by a staff appraiser of said City, is the sum of Sixty-Five Dollars (\$65.00); and

WHEREAS, no real estate broker's commission shall be paid; and

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document , quitclaiming to Deville Development Inc., a California Corporation, that certain easement for drainage purposes affecting Lot 12 Block 2 of Essex Place and a portion of Pueblo Lot 1125, as more particularly described in said form of quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
