WHEREAS, the City and County of San Diego have since 1948 jointly sponsored a School Safety Patrol Summer Camp for graduating students; and

WHEREAS, the County of San Diego has decided to no longer participate in said School Safety Patrol Summer Camp; and

WHEREAS, it is necessary to provide additional funds to the Police Department to provide for that portion formerly funded by the County for the 1976 and 1977 Summer Camps; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$25,215 from the Unallocated Reserve (53.31) to the Police Department Traffic Operations (15.32) to provide necessary funds for the operation of the 1976 and 1977 San Diego School Safety Patrol Summer Camps, said funds representing that share formerly funded by the County.
