A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 754397, AS AMENDED, BY ADDING PROJECT NO. 11-153, ENTITLED "CENTER STREET AND EAST BEYER BOULEVARD DRAIN," TO THE FISCAL YEAR 1977 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS IN THE SUM OF \$60,000 FOR THE ABOVE PROJECT.


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 2, subsection 23 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 754397, as amended, be and the same is hereby further amended by adding C.I.P. Project No. 11-153, Center Street and East Beyer Boulevard Drain to the fiscal year 1977 C.I.P. Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer to said Project No. 11-153 the sum of \$24,000 from C.I.P. No. 90-245, Capital Outlay Fund Reserve and \$36,000 from C.I.P. No. 90-220, Gas Tax Fund Reserve.
