

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$685,275 from Environmental Growth Fund 2505, \$39,050 from Park & Recreation Bond Fund 725, and \$1,950 from Park District Fund 11191 is hereby authorized solely and exclusively for the purpose of providing funds, in addition to those previously allocated, for the City's contribution in the total amount of \$1,198,875 for improvements in San Diego Park District No. 10 (Crest Canyon Open Space Park Reserve), as more particularly described in Resolution of Intention No. 217436 and pursuant to the San Diego Park District Procedural Ordinance of 1969 and the Municipal Improvements Act of 1913.
