Community Park, South Chollas Creek Flood Channel, Southeast Sports Field, Southeast Sports Field Field House, Bay Bridge Park, Air-conditioning Neighborhood Facility, Boys' Club Natatorium, Paradise/Barrio-Logan Senior Center, San Ysidro Senior Center Addition, San Ysidro Fire Station, Sports Field - San Ysidro, provided that plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for said approved public works of improvement shall be filed in the office of the City Clerk of The City of San Diego, California, prior to any publishing being made hereunder.

2. That by Resolution No. 215808, adopted April 21, 1976, this Council ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said resolution is the said current or prevailing rate for the various crafts that will be applicable to projects approved and constructed pursuant to the Housing and Community Development Act of 1974.
