A RESOLUTION FLECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF CORONADO AVENUE AND HOLLISTER STREET, ADJACENT TO LOT 24, NESTOR ACRES, MAP NO. 1768, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.
