WHEREAS, in November 1975, Mr. Frank Curran was requested by Mr. Floyd Morrow, Chairman of the Public Facilities and Recreation Committee, to convene a representative ad hoc committee to develop a set of recommendations on what to do with regard to improving Horton Plaza and on November 5, 1976, Mr. Curran submitted a five-page report of the Horton Plaza Study Committee; and

WHEREAS, on December 15, 1976, the Assistant City Manager submitted a memorandum to the Public Facilities and Recreation Committee in which some 10 items identified by the Ad Hoc Committee were recommended for implementation; and

WHEREAS, on December 20, 1976, the Public Facilities and Recreation Committee moved to adopt the recommendations of the Manager's December 15, 1976, memo; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of \$60,000 from the General Fund 100 by various City departments for the purpose of refurbishing Horton Plaza is hereby approved.

BE IT FURTHER RESOLVED, that no news racks shall be allowed within the immediate Plaza area and that the City Manager take appropriate steps to have the existing news racks removed.

BE IT FURTHER RESOLVED, that the City Manager is hereby requested to report back to the City Council on potential traffic problems relative to prohibiting left-hand turns at 4th and Broadway.
