BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of \$60,000 from the General Fund 100 by various City departments for the purpose of refurbishing Horton Plaza is hereby approved.

BE IT FURTHER RESOLVED, that no news racks shall be allowed within the immediate Plaza area and that the City Manager take appropriate steps to have the existing news racks removed.

BE IT FURTHER RESOLVED, that the City Manager is hereby requested to report back to the City Council on potential traffic problems relative to prohibiting left-hand turns at 4th and Broadway.

BE IT FURTHER RESOLVED, that the use of City forces to do
the refurbishing of Horton Plaza, as set out in the Manager's
Report to the Public Facilities and Recreation Committee, which
report is dated December 15, 1976, and a copy of which is on
file in the office of the City Clerk as Document No. 758873
is hereby approved.
