

The City Manager is hereby authorized and empowered to execute, for and on behalf of City, an agreement with R. E. HAZARD CONTRACTING COMPANY, a California corporation, and MURRAY PROPERTIES INC., a California corporation, for the modification of an existing traffic signal and construction of street improvements at the southwest corner of Ruffin Road and Clairemont Mesa Boulevard, within the limits of HAZARD COMMERCIAL PARK subdivision, and to provide for reimbursement by the City out of Capital Outlay Fund 245 from the Annual Allocation, New Developments, CIP 58-001, in an amount of \$12,392.00, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 758402.
