WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where those streets to be vacated has been superseded by relocation; and

WHEREAS, portions of FARNHAM STREET, LACOTA AVENUE and CLAIREMONT MESA BOULEVARD have been relocated by the approval on this date of the dedication of replacement streets by the acceptance of the final map of the subdivision to be known as HAZARD COMMERCIAL PARK; and

WHEREAS, those properties adjoining the streets to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as HAZARD COMMERCIAL PARK: NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That FARNHAM STREET, LACOTA AVENUE and a portion of CLAIREMONT MESA BOULEVARD as more particularly shown on Drawing No. 16989-D on file in the office of the City Clerk as Document No. 758396, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.
