That FARNHAM STREET, LACOTA AVENUE and a portion of CLAIREMONT MESA BOULEVARD as more particularly shown on Drawing No. 16989-D on file in the office of the City Clerk as Document No. 758396, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.
