Accepting the alternate bid of Clark Truck Equipment Company, Fire Apparatus Division, for furnishing eight (8) 1500 Gallon Triple Combination Pumpers without additional equipment for a cost of \$73,227.00 each, less trade-in allowance of \$1,500.00 each for eight (8) used pumper trucks with an option to purchase two additional units at the same prices and terms by March 1, 1977; and for two (2) Brush Rigs without additional equipment for a cost of \$57,555.00 each, less trade-in allowance of \$1,000.00 each for two (2) used brush rigs; for a total cost of \$728,981.56 including tax, terms and trade-ins.
- 2. Accepting the alternate bid of Sutphen Corporation for two (2) Brush and Structural Fire Apparatus without additional equipment for a cost of \$62,833.00 each, less trade in allowance of \$500.00 each for two (2) used pumper trucks; for a total cost of \$132,205.96 including tax, terms and trade-ins.
- 3. Accepting the alternate bid of Halprin Supply Co. for additional equipment for eight (8) 1500 Gallon Triple Combination Pumper trucks at a cost of \$5,842.01 each; for additional equipment for two (2) Brush Rigs at a cost of \$1,703.50 each; and for additional equipment for two (2) Brush and Structural Rigs at a cost of \$5,837.51 each; for a total cost of \$65,527.19 including terms and tax.
