WHEREAS, the Allied Gardens Recreation Council, formed to promote the programs of the Allied Gardens Park and Recreation Center, as an act of civic generosity, has offered to contribute to The City of San Diego the sum of \$450 to assist the City in purchasing a set of uneven parallel bars needed for the Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$450 from the Allied Gardens Recreation Council and directs that said contribution be deposited in Capital Outlay Fund 245 and thereafter be matched by an additional \$450 from The City of San Diego to be used exclusively for the purpose of purchasing a set of uneven parallel bars to provide the needed equipment to carry out the gymnastics program at the Allied Gardens Park and Recreation Center.

2. That the expenditure of \$450 from the Capital Outlay Fund 245 is hereby authorized solely and exclusively for the purchase and installation of uneven parallel bars at the Allied Gardens Park and Recreation Center.

3. That this Council does hereby commend the Allied Gardens Recreation Council for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the Allied Gardens Recreation Council.
