

RESOLUTION NO. 217789 FEB 23 1977R. 77-1358

WHEREAS, the Colina del Sol Recreation Council, formed to promote the programs of the Colina del Sol Park and Recreation Center, as an act of civic generosity, has offered to contribute to The City of San Diego the sum of \$493 to assist the City in purchasing basketball backboards needed for the Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$493 from the Colina del Sol Recreation Council and directs that said contribution be deposited in Capital Outlay Fund 245 and thereafter be matched by an additional \$493 from The City of San Diego to be used exclusively for the purpose of purchasing basketball backboards for the Colina del Sol Park and Recreation Center.

2. That the expenditure of \$493 from the Capital Outlay Fund 245 is hereby authorized solely and exclusively for the purchase and installation of basketball backboards at the Colina del Sol Park and Recreation Center.

3. That this Council does hereby commend the Colina del Sol Recreation Council for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the Colina del Sol Recreation Council.
