

RESOLUTION NO. 217790 FEB 23 1977

WHEREAS, The City of San Diego, California has entered into a contract with the U. S. Department of Housing and Urban Development (HUD) to carry out, within The City of San Diego, a housing and community development program; and

WHEREAS, the City Council on November 26, 1974 by Resolution No. 212090 allocated \$430,468 for commercial development from The City of San Diego's First Year Block Grant Application; and

WHEREAS, the successful implementation of the Imperial Avenue Commercial Improvement Project requires the use of Block Grant Funds in the estimated amount of \$190,000; and

WHEREAS, remaining funds are insufficient for implementation of the Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the scope of services, work program and budget for the Imperial Avenue Commercial Improvement Project as set forth in the document on file in the office of the City Clerk as Document No. 758430 be, and the same are hereby approved.

2. That the City Manager or his designee is hereby authorized to transfer the sum of \$81,589 from Block Grant Fund 290, Activity 87.95 (Contingencies and Unspecified) to Fund 290, Activity 87.23 (Imperial Avenue Commercial Improvement).


