

RESOLUTION NO. 217792

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

In considering Environmental Impact Report No. 76-09-26 P
the following findings are made:


A. Noise impact from I-5 and State Highway 75, are
reduced to the level of insignificance by virtue of the
development being located below the grade of State Highway 75
and 500 feet away from I-5.

Noise impacts from helicopter overflights are incapable
of reduction to levels of insignificance because the costs
of construction to reduce these impacts will increase the
cost of housing beyond the means of those most in need of such
shelter.

B. Air pollution and its impact on the site is not within
the economic realm of feasibility for the developer to control.
Conditions at the site are no worse than exist generally in
the area. Since much of the air pollution emanates from
uncontrolled sources in Mexico, the developer cannot mitigate
this situation.

C. Geological questions will be answered by soils analysis
performed in conjunction with the map process, thereby mitigating
any impacts that are identified.
