WHEREAS, the effective period of that resolution was extended by Resolution No. 216424 to February 28, 1977; and

WHEREAS, the City Manager desires to utilize program savings from the prior operating periods to extend the operation of the Housing Rehabilitation/Code Enforcement Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to continue implementation of the Housing Rehabilitation/Code Enforcement Program utilizing the Housing and Community Services Department as the operating department to carry out this Community Development Block Grant project in the Balboa School/Educational Cultural Complex areas during the period between February 28, 1977 through June 30, 1977.
