Lorraine A. Ashabraner	General Services	\$385	At the time of his suggestion, Mr. Ashabraner was a Foreman in the Equipment Division. He suggested that a coolant system preventative maintenance program be initiated for City vehicles. After experimentation with various kinds of coolants, such a program has been initiated. This suggestion is expected to save \$3,854 in the first year of operation.
John A. Barton	Property	\$110	Mr. Barton is a Gardener Supervisor at the San Diego Stadium. He designed a drag float for use in maintaining the field at the Stadium. Mr. Barton's design could not be purchased on the open market. In addition to the use at the Stadium, the Park and Recreation Department also had the design fabricated. This suggestion has saved the City \$1,104 in maintenance costs.
