

RESOLUTION NO. 217799Adopted on MAR 2 1977

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Alvin A. Beckett	Police	\$ 90	Mr. Beckett is a Detective in the Investigations Bureau. He suggests a change in the Municipal Code concerning the licensing of games of skill. This change resulted in an estimated \$898 of savings per year in labor and material costs.
Robert W. Lindstrom	Police	\$ 45	Mr. Lindstrom is a Lieutenant in the Patrol Bureau. He suggested a change in the telephone lines of the Northern Division Substation. This revision saves the City \$471 a year in telephone charges.
Albert E. Bruton, Jr.	Park and Recreation	\$ 45	Mr. Bruton is a Lifeguard Lieutenant in the Aquatics Division. He designed a form that takes the place of six forms formerly used by Lifeguards. This suggestion is expected to save \$434 per year in printing costs and man hours.
Thomas B. Frost	Park and Recreation	\$ 25	Mr. Frost is a Senior Engineering Aide in the Park Division. He suggested that C.I.P. numbers be placed on "as built" drawings to save time in researching this number. It was decided that these numbers were not needed on "as built" drawings but would save time if placed on initial plans. A saving of \$250 is estimated.
