WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Lucille S. Alexopoulos	Employee Services	\$ 10	Ms. Alexopoulos is an Intermediate Typist in the Public Liability Program. She suggested that claims file folders be printed on both sides for re-use. This will save \$115 per year in printing costs.
E. Lorraine Payne	Employee Services	\$ 10	Ms. Payne is an Intermediate Typist in the Insurance Services Program. She suggested that five form letters be combined. This saves \$103 per year in copying and processing costs.
Charles R. Minton	Park and Recreation	\$ 10	Mr. Minton is a Recreation Facility Caretaker in the Recreation Division. He suggested that a safety inspection checklist be printed on both sides to reduce the flow of paper. This is expected to save \$100 per year in printing and labor costs.
Alvus L. Ramsay	Fire	\$ 10	Mr. Ramsay is a Fire Fighter. He suggested that all Accident Review Board Findings be posted in all Fire Stations. Although no savings in accidents can be assured, this is felt to be a significant safety suggestion.
