

Arrieta & Son, Inc., a corporation, for the CONSTRUCTION OF THE POINT LOMA WASTEWATER TREATMENT PLANT SLUDGE LINE REPLACEMENT in the City of San Diego, California, is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757899.

2. That the City Auditor and Comptroller is hereby authorized to advance \$1,073,000.00 from Sewer Revenue Fund (Fund 506), Unallocated Reserve (69.97) to the Public Works Employment Act-Point Loma Sludge Line Replacement Grant Fund (Fund 2723) for CONSTRUCTION OF THE POINT LOMA WASTEWATER TREATMENT PLANT SLUDGE LINE REPLACEMENT in the City of San Diego, and related costs.
