

WHEREAS, a certain sewer easement was dedicated in the Northeast Quarter of the Northwest Quarter of Section 30, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to official plat thereof; and

WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City of San Diego by this resolution does hereby abandon whatever right, title or interest it may have in that sewer easement more particularly described as follows:

Beginning at the intersection of the center line of Revelstoke Way with the easterly boundary of Larwin Mesa View Addition Unit No. 1 as shown on Map thereof No. 7106 filed in the Office of the Recorder of said San Diego County;

Thence North 0°01'50" East along the east line of said Larwin Mesa View Addition No. 1 a distance of 1.49 feet;

Thence North 81°29'30" East a distance of 99.45 feet to the TRUE POINT OF BEGINNING of the portion to be described being a point on a 268.00 foot radius curve concave northwesterly, a radial line to said point bears South 35°36'25" East;

Thence northeasterly along said curve through a central angle of 4°22'20" for an arc distance of 20.45 feet;

Thence North 81°29'30" East a distance of 200.97 feet;

Thence South 8°30'30" East a distance of 20.00 feet;



Thence South 81°29'30" West a distance of 240.72 feet to a point on said 268.00 foot radius curve concave northwesterly;

Thence northeasterly along said curve through a central angle of 5°09'08" for an arc distance of 24.10 feet to the TRUE POINT OF BEGINNING of the portion described.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder of said County of San Diego.
