WHEREAS, PACIFIC SCENE, INC., by T. G. Schowalter, vice president, applied to the City for special permission to waive underground utility requirements in connection with the subdivision map of SUNRISE ADDITION; and

WHEREAS, the City Council conducted a hearing on the application on March 2, 1977, and considered the facts of the case as presented by the applicant and City staff; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the application of PACIFIC SCENE, INC., by T. G. Schowalter, vice president, for special permission to waive underground utility requirements in SUNRISE ADDITION is hereby granted with the following conditions stipulated by staff:

1. Developer be required to install all necessary conduit and concrete substructures and make arrangements with the utility company to eliminate any conflict between the overhead wiring and any required street lights; and

2. Developer be required to deposit with the City a guaranty to cover the cost of future undergrounding of this system to the amount of \$5,000.
